J. A.S. Promotional Shirts (Informational): V.P.F. Gutierrez-Guler presented two estimates from outside vendors for promotional A.S. T-Shirts. The first estimate is for a red T-Shirt with the A.S. logo on the upper left side of the shirt. The second estimate is also for a red promotional T-Shirt with the A.S. logo on the upper left side and a complete image, including a quote on the back. The first vendor, "Franks Graffik," quoted six-hundred fifty-seven dollars and fifty cents (\$657.50) for one-hundred (100) T-Shirts with the A.S. logo on the front. The second vendor, "KazBros," will charge one-thousand seventy-six dollars and forty-three cents (\$1,076.43) for one-hundred (100) T-Shirts with the A.S. logo on the front. They estimate the cost to be one-thousand four hundred fifty-three dollars and fifty-five cents (\$1,453.55) for T-Shirts printed with the A.S. logo on the front and full image on the back, including a quote.
